CANCELLATION PROCEDURE

Upon Cancellation, submit the following information to the Administrator:

- ☐ This form with the Cancellation Section completed and signed by the contract holder and a dealership representative.
- ☐ The original vehicle service contract or a notarized affidavit that the contract was destroyed or lost.
- ☐ A Federal Odometer Statement or notarized affidavit verifying mileage at the time of request.
- ☐ If repossessed: Supply copy of repossession papers.
- ☐ If totaled: Supply copy of insurance company's verification of loss.
- ☐ If lien has been paid: Supply copy of discharge from lienholder.

TRANSFER PROCEDURE

Upon Transfer, submit the following information to the Administrator:

- ☐ This form with the Transfer Section complete and signed by the contract holder and a dealership representative.
- ☐ A Transfer fee of \$50.00 (fee may vary depending on state, see service contract for details).
- ☐ The original vehicle service contract or a notarized affidavit that the contract was destroyed or lost.
- ☐ Maintenance log/service receipts verifying that all maintenance requirements have been met.
- ☐ A copy of documentation evidencing change of ownership and mileage at date of sale.
- ☐ Photocopies of documents sent to the manufacturer verifying transference of factory warranty, if applicable.

TRANSFER CONDITIONS

- A contract cannot be transferred to another vehicle. It can only be transferred to a different private owner of the same vehicle.
- The vehicle is subject to inspection.
- Transfer must take place within 15 days of change of ownership.
- The contract may not be transferred to a vehicle dealer or to the customer of a vehicle dealer.
- Contracts on leased vehicles cannot be transferred, unless the vehicle is being purchased by original lessee.
- All remaining underlying warranties must be transferred to the new owner.
